

After serving for 4 years as the Mentorship, Advocacy and Peer Support Program Coordinator at CASA First, Veronica now serves as the Vice President of the organization's Board of Directors. In the Fall of 2022, Veronica began her venture into the New Mexico Legislature and now serves as the Leadership Analyst for the New Mexico House of Representatives Majority Office. After graduating from Fort Lewis College in 2017, Veronica returned home to New Mexico to follow her passion for supporting and working alongside young people involved and impacted by the child welfare system.

Having been through the child welfare system herself, Veronica is passionate about preventative services, lived experience voice, and advocating for the holistic well-being of children, youth, and families. Her current child welfare advocacy includes service as a senior member of the National Foster Youth and Alumni Policy Council, a member of the National Child Welfare and Racial Equity Collaborative, and as Co-Chair of the Training Committee for the New Mexico Partners.


